4. Discussion of Silver Lane Revitalization Area Redevelopment Plan Draft

The revised draft will be posted on the Redevelopment Agency webpage on Thursday, May 19, for public review, in advance of the public meeting to take place on Wednesday, May 25, at 6:30 PM in the Town Council Chamber. The plan will then be referred to the Planning & Zoning Commission for their June 8 meeting, return to the Redevelopment Agency for approval after a 35-day waiting period for a special meeting in July, and then move to the Town Council for final approval in August.

The Goman & York team presented the adjustments to the draft based on the comments from the members at the prior meeting. This included a map showing minimal potential of residential displacement, a map showing the properties with the highest prioritiy for redevelopment, a note emphasizing the potential for small-scale businesses and services, and a more detailed explanation of demographic segmentation. The team will bring a poster-sized image of the area to the public meeting.

Mr. Matta suggested updating the section on prior planning studies to note whether they are being endorsed, rejected, or simply included for reference, and potentially moving them to the appendix. Mr. Ryan suggested considering the new plan during the next update of the Plan's Conservation & Development.

5. Project Updates

Construction is continuing at the Downey Building. The Town has lauched a Small Business Assistance Program funded by ARPA and is partnering with the CT River Valley Chamber of Commerce to promote it.
