EAST HARTFORD HIGH SCHOOL TENNIS COURT RENOVATIONS

Work under this contract includes renovations to the existing tennis courts located in the western portion of the East Hartford High School (EHHS) property in the Town of East Hartford. The Work includes repair of the existing court surfaces (east four [4] tennis courts only) and full reconstruction of the four (4) west tennis courts with the installation of underdrains. Appurtenant work includes replacement of all fence fabric & gates, new tennis court equipment, new tennis court surface/lines, installation of electrical ducts for new sports lights, bituminous concrete walks, installation of benches & trash cans and maintenance and protection of traffic.

Sealed Bids will be received at the office of the Purchasing Department, Town Hall, 740 Main Street, East Hartford, CT 06108 until 11 A.M., WEDNESDAY, JUNE 17th, 2015 at which time and place said bids will be opened publicly and read. Bids may be hand delivered to the above address or mailed (USPS, UPS, FedEx) to the Purchasing Dept, Town of East Hartford, Town Hall, 740 Main Street, East Hartford, CT 06108.

The Town will conduct a MANDATORY PRE-BID MEETING on TUESDAY, JUNE 9TH, 2015 AT 10 A.M. AT THE TENNIS COURT COMPLEX, EAST HARTFORD HIGH SCHOOL, 869 FORBES STREET, EAST HARTFORD, CT 06108. Bids submitted by firms who have not attended or were not represented at the pre-bid meeting will be rejected and returned unopened.
