The East Hartford Parks and Recreation Department would like to welcome you to join us for the **27th Annual Fall Festival scheduled for Saturday, October 1st from 11:00am—3:00pm on the East Hartford Town Green (50 Chapman Place)**. Fall Fest is one of the largest events the town hosts which features vendors, crafters, musicians, entertainment, carnival games, inflatables, face painting, pumpkin decorating, scarecrow decorating and many other family oriented activities.

Food Vendors of all sorts are accepted on a first-come, first-served basis. Spaces are marked on concrete and grass areas at the Town Green. Electricity is not available. Vendors are responsible for providing their own chairs, and canopy tents as well as responsible for securing those tents and all property/ merchandise from wind or inclement weather. Any display, merchandise, or tables/chairs must be within the space perimeters and may not extend into the walkways or another adjacent space. Vendors are required to stay for the full duration of the event and will not be allowed to leave the grounds until after the event has concluded.

Space fees are non-refundable. Full payment must accompany the completed application form (See back for more information.) In the event of inclement weather, the event will be held on Sunday, October 2nd instead, same location and time. All vendors must be able to commit to both the event and rain date to be considered as a 2016 Food Vendor.
