Dance – April in Paris: Reggie Barall commented on the great turnout she had. Susan Tukey discussed the program and felt it should have been announced it was a tribute to Herbert Barall. The Chair would like to see an evaluation of this program and what types of dance programs we want to sponsor.

Dance - Around the World: Reggie Barall reported that in honor of Armed Forces Day, Circle of Life, Arts for All presents a tribute to our military – current, veterans and those lost in war – with a celebration on Sunday, May 20, 2018 in their studio at the EHCC, 50 Chapman Place, East Hartford. The celebration, from one o'clock to four o'clock in the afternoon, will highlight the stories, music and dance of the Great Wars, World Wars I and II. The event is free, open to the public and co-sponsored by the Commission on Culture and Fine Arts." Prescille Yamamoto commented on the great advertisement placed in The Gazette for this program.
