Sarah showed a PowerPoint of the Library's Directory Tree. There are 15 full time and 25 part time staff. Sarah explained what the director oversees, what the assistant director oversees and the responsibilities of each employee.

The library will be fine free as of July 1.

The Intersections Concert Series with 5 concerts had a total attendance of 479 people.

Chair asked about the summer reading program. Sarah clarified that it is set your own goal but with a minimum of 2 books must be read.
