Ms. Shaw presented a sign application for Snipes, the store that has replaced EbLens in the redevelopment site at 20 Burnside Avenue. It will also require approval from the Planning & Zoning Commission.

6. Project Updates

Ms. Buckheit presented project updates beginning with Silver Lane Plaza, where the Town has been working to relocate tenants since taking ownership of the property. Je Mart and Bare Bones Boxing have left their units, leaving the rear building empty. Living Word Imprints is moving out of 804 Silver Lane and will reopen across the street at 775 Silver Lane. The bid for demoltion of the rear building is open, and the Town received one RFP response for eventual mixed-use redevelopment of the entire property.

Construction of the Habitat for Humanity project at 550 Burnside Avenue is on schedule and moving ahead. The former Daley Court property at 590 Burnside Avenue is being used for parking for the construction project under a two-year agreement.
