TYPE OR WRITE IN:

- (1) the full legal name of the contractor.
- (2) the contractor's <u>form of organization</u>.(ex., Corporation, Limited Liability Company, Partnership, Sole Proprietor)
- (3) the <u>name of the person</u> who is authorized by the contractor to sign as principal on page 2.
- (4) the <u>correct title</u> of the person named in (3). (ex., Corporations [President, Vice President, Secretary, Treasurer], LLC [Member or Managing Member], Partnership [Partner, General Partner].
- (5) the <u>name of the bonding (insurance) company</u>. (The full name of the underwriting company must appear; not the name of the agent, agency or broker.)
- (6) the <u>name of the authorized Agent</u> at the bonding company who will be signing the Bond on page 2 under "<u>SURETY</u>". See (14a,b,c).
- (7a,b,c) the <u>beginning date</u> of the Bond's term of coverage.
- (8a,b,c) the ending date of the Bond's term of coverage.
- (9) the **full legal name of the contractor** same as (1).
- (10) the full legal name of the contractor same as (1).
- (11) the city and state where the Bond was produced.
- (12a,b,c) the \underline{day} , \underline{month} and \underline{year} the Bond was produced.

THEN:

- (13a,b,c) The Principal same as (3) must fill in <u>Signature</u>, <u>Printed Name</u>, and <u>Title</u> same as (4), and affix the corporate <u>SEAL</u>, if a corporation.
- (14a,b,c) The authorized Agent same as (6) must fill in <u>Signature</u>, <u>Printed</u> <u>Name</u>, and <u>Title</u>, ("Attorney In Fact"), and affix the company <u>SEAL</u>.
- (15a,b) The person witnessing the Principal's signature see (13a) must <u>sign</u> and <u>print</u> his/her <u>name</u>.
- (16a,b) The person witnessing the Agent's signature see (14a) must sign and print his/her name.

ALSO:

- The Bond must be filled out completely, including signatures. Do not leave any spaces blank.
- A <u>Power of Attorney</u> form must be attached to the Bond. The dates on the POA must be consistent with the dates on 12a, 12b and 12c of the Bond.
- The person named on the **Power of Attorney** must be the same as (6) & (14).
