Greetings Future Food Vendor,

The Town of East Hartford would like to welcome you to join us for the Juneteenth Family Celebration scheduled for Saturday, June 15th from 11:00 am—4:00 pm on the East Hartford Town Green (50 Chapman Place). According to the 2020 Census Report, East Hartford is ranked second as the most diverse town in Connecticut. We expect this event to be one of our biggest family event of the season for everyone. On this day of Recognition, Restoration, and Celebration we embrace as a town our uniqueness and enrichment with crafters, entertainment, carnival games, inflatables, face painting, and many other family-oriented activities.

Food Vendors of all sorts are accepted on a first-come, first-served basis. Spaces are marked on concrete and grass areas at the Town Green. Electricity is not available. **If not a food truck please note that vendors are responsible for providing their chairs, and canopy tents as well as responsible for securing those tents and all property/merchandise from wind or inclement weather.** Any display, merchandise, or tables/chairs must be within the space perimeters and may not extend into the walkways or another adjacent space. Vendors are required to stay for the full duration of the event and will not be allowed to leave the grounds until after the event has concluded.

Space fees are non-refundable. Full payment must accompany the completed application form (See back for more information.) In the event of inclement weather, the event will be held indoors at the Community Cultural Center. Food vendors will be set up outside of the building.
