- All work in the Inland Wetlands and/or Inland Wetland Upland Review Area shall be commenced within five (5) years from the effective date. The activity shall be completed within three (3) years from the commencement of the activity.
- Written notice shall be submitted to the Town Designated Wetlands Agent 48 hours prior to the starting date of the approved activity.
- In evaluating this application, the Inland Wetlands Environment Commission has relied
 on information provided by the applicant, and if such information subsequently proves to
 be false, deceptive, incomplete and/or inaccurate, this permit shall be modified,
 suspended, or revoked.
- Approval is granted based on the maps submitted with the application with plans dated January 9, 2023.
