- Written notice shall be submitted to the Town Engineer 48 hours prior to the starting date of the approved activity.
- In evaluating this application, the Inland Wetlands Environment Commission has relied on information provided by the applicant, and if such information subsequently proves to be false, deceptive, incomplete and/or inaccurate, this permit shall be modified, suspended, or revoked.
- Approval is granted based on the maps submitted with the application with plans dated May 2021.

> B. File #21-11, Application of Alain Gilles to conduct a regulated activity in an Inland Wetlands Upland Review area in conjunction with the construction of a garage at 97 Leverich Drive.
