### > CORPORATION COUNSEL JAMES N. TALLBERG

- Jim is the Managing Partner of Karsten & Tallberg, LLC, a five-lawyer firm dedicated to the representation of public entities and officials. Since 1996, Jim and the members of his firm have represented a majority of the 169 municipalities in Connecticut. Since 2020, he has also served as the Town Attorney for the Town of Enfield.
- He is a former Chairman of the Rocky Hill Charter Revision Commission and serves as a Hearing Officer by appointment of the Rocky Hill Town Manager. He is a member of the Federal Bar Council, Connecticut Bar Association, Hartford County Bar Association, Defense Research Institute, Connecticut Defense Lawyers Association, and serves as an elected member of the Board of Directors of the Connecticut Association of Municipal Attorneys ("CAMA").


#### > PART-TIME ASSISTANT CORPORATION COUNSEL RICHARD P. GENTILE

The office works closely with all departments of Town government in providing legal representation with respect to the rights and responsibilities of Town departments, the Town Council, the Board of Education and appointed Boards and Commissions.

- The Corporation Counsel's Office acts as the legal advocate for the Town in all actions, suits, or proceedings brought by or against it or any of its departments, officers, agencies, boards or commissions.
- The Corporation Counsel's office drafts and/or reviews all third party contracts, comments on new or revised Town Ordinances, routinely advises boards and commissions including Planning and Zoning, the Zoning Board of Appeals and the Inland-Wetlands Agency and is responsible for legal work associated with the conveyance or acquisition of real estate.

#### Representative Accomplishments:

- Recruitment of full-time Assistant Corporation Counsel
- Negotiate the acquisition and sale of numerous properties including Church Corners Inn located at 860 Main Street, Burnside Avenue redevelopment property to Habitat for Humanity.
- Development and tax agreement that will foster the creation of 400+ market-rate apartments at the former Showcase Cinemas site.
- The acquisition of Applegate Lane.
- Adoption of the Silver Lane Redevelopment Plan.
- Series of Easements along Silver Lane to enable construction of sidewalks in the area.
