Application of Steven Kaplan to Rezone a Portion of 65 Goodwin

Street, East Hartford, Connecticut to the Industrial 2 Zone

Dear Mr. Bonzani:

On behalf of our client, Steven Kaplan, I am pleased to enclose an Application for Zoning Map Change to change the zone of the front portion of the property located at 65 Goodwin Street (the "subject property") from Residential 2 ("R-2") to the Industrial 2 ("I-2") zone. The balance of the subject property is already zoned I-2. Mr. Kaplan is under contract to purchase the property from the current owner, Michael H. Ravalese.

The subject property consists of approximately 2.13 acres of land. An abandoned single family residence, currently wrapped in Tyvek paper, is located on the front, R-2 part of the property. The remaining I-2 section (approximately two-thirds of the site) is vacant. South and east of the parcel is land zoned I-2. The properties to the west of the parcel are zoned R-2, and the land north of the property is zoned R-3.

If the Commission approves this zone change application, Mr. Kaplan plans to file a site plan application to construct on the subject property a self-storage facility consisting of two free-standing, one-story buildings containing approximately 165 storage units. Public storage is a permitted use in the I-2 zone. He would also build a small cape-style building on the front end of the property near Goodwin Street to use as an office for a facility manager. Mr. Kaplan would retain a 50-foot landscaped buffer between the selfstorage facility and the rear yards of the homes on Tiffany Road to the west of the parcel.

Given its long and narrow configuration, the subject property likely could not support the development of any other permitted use in the I-2 zone, such as manufacturing or offices, given the parking demand that such uses would generate. A self-storage facility, by contrast, requires minimal parking spaces and is a low-intensity use that will serve as an appropriate transition between the R-2 and I-2 properties.

The proposed zone change will benefit the Town of East Hartford by allowing the productive build-out of a property that is mostly zoned I-2 but cannot be used for light industrial purposes. That is because, under Section 204 of the East Hartford Zoning Regulations, a private driveway servicing an industrial use may not be constructed through a Residential zone. Providing a consistent set of rules on this property would enable economic development and will advance the general planning goal of avoiding split-zoned properties. Moreover, it would allow a much-needed redevelopment to occur on a property that has become an eyesore for the neighborhood.

Rezoning the front portion of the parcel to I-2 also would be consistent with the 2014 East Hartford Plan of Conservation and Development ("POCD"). Specifically, the Future Land Use Plan (Figure 48) recommends that the entire parcel be zoned for Light Industrial use. As such, granting this application would implement the Commission's preferred plan for the future zoning of the property.

The proposed zone change also advances several goals set forth in the POCD. For example, Section 3.1 states a land use and zoning goal of promoting balanced use of land to enhance fiscal benefit and protect quality of life. Section 10.1 lists goals that include promoting economic development activity to attract new business opportunities, and building on the existing industrial and manufacturing base to promote new diversified business investment. These goals would be achieved by enabling Mr. Kaplan to develop the entire parcel with a low-impact use permitted by right in the I-2 zone.

In addition to this letter, we are submitting to you today twelve (12) copies of the application for zoning map change, property description, zoning map showing the boundary lines of the proposed zone change, aerial photo of the existing use of the property, site plan rendering showing the proposed use of the property, authorization letter from the property owner, 500-foot abutters list, and a check in the amount of \$260.00 for the application filing fee.














## 65 Goodwin St: 500 ft. Abutters Map
