NEW BUSINESS

A. ZONING TEXT AMENDMENT

Applicant: East Hartford Planning and Zoning Commission

Upon a motion by Mr. Soderholm to move Text Amendment, Ms. Noel seconded. Commission voted (4-0) All in favor, motion passes.

OTHER BUSINESS

John Guszkowski of Tyche Planning and Policy Group showed Power Point presentation explaining data and reported on East Hartford's Affordable Housing Plan. A State mandate in 2017 statute that every 5 years towns need to decide on how they are going to increase the number of affordable housing. The goal is 10% of housing must be affordable.

Next steps – Public Hearing Drafting narrative Regulations Recommendations for action

Chair Ryan asks if there are any questions-

East Hartford is 5% over min; with Silver Lane Apartments planned are at market value; will it reduce % of affordable housing? *Discussion -The apartments would not hit the list until 2030*

How do we account for the over inflated housing rate? Discussion/answer-State does not tract cost burden.

Comment-Mr. Hnatuk -not specifically about apartments; assistance from subsidized units does count as affordable units.

Mr. Marra questions on any benefits from State if our % is higher? Answer is no incentive

Chair Ryan asks if there are any more questions.

Recap of next steps Mr. Guszkowski will come back at next meeting with draft of recommendations. Any further comments?

MISCELLANEOUS

Ms. Noel questions how best to make use of both previous and Interim Planner-

Mr. Solderholm asks about letters sent from the City of Hartford regarding Text Regulations. *Answered* by Mr. Hnatuk that they are letters to review only.
