SITE PLAN MODIFICATION: 1 Pent Road – Under Section 702; new construction of a manufacturing annex building and reconstruction of the parking area extending to Riverside Drive for "Goodwin College".

Applicant: Goodwin College, Inc.

Upon a motion by John Ryan, seconded by Hank Pawlowski, the Commission **Voted** (6-1 *Nay: Simpson*) to **approve** the above site plan modification application with the following conditions:

- 1. Final plans are to be signed and stamped (ink & impression) by the Professional Engineer, Land Surveyor or Architect licensed in the state of Connecticut who is responsible for the work.
- 2. In evaluating this application, the Planning and Zoning Commission has relied upon information provided by the applicant and, if such information subsequently proves to be false, deceptive, incomplete, and/or inaccurate, this permit shall be modified, suspended or revoked.
- 3. Show a Location Plan on the Record Subdivision Map.
- 4. Show how detention was sized and provide design details.
- 5. Cover on CB #6 is only about 12". Show what type of pipe is proposed that can handle this type of loading.
- 6. Show where 30" RCP goes. Does this pipe outlet to a Town of East Hartford storm water system or outfall? If so, the additional Directly Connected Impervious Area created must be disconnected from the Town's outfall.

SOIL EROSION AND SEDIMENTATION APPLICATION: 1 Pent Road – Under section 217; disturbance of approximately 142,020 sq. ft. of land for construction of the manufacturing annex building and parking area for "Goodwin College".

Assessor's Map-Lot: 9-1

Applicant: Goodwin College, Inc.

Upon a motion by John Ryan, seconded by Hank Pawlowski, the Commission **Voted (7-0)** to **approve** the above soil erosion and sedimentation control application with the following conditions:

- 1. Final plans are to be signed and stamped (ink & impression) by the Professional Engineer, Land Surveyor or Architect licensed in the state of Connecticut who is responsible for the work.
- 2. In evaluating this application, the Planning and Zoning Commission has relied upon information provided by the applicant and, if such information subsequently proves to be false, deceptive, incomplete, and/or inaccurate, this permit shall be modified, suspended or revoked.
- 3. Applicant to provide a financial guarantee for soil erosion & sedimentation control in the amount of \$15,700.00.

• **BOND SETTING:** 1 Pent Road – Soil and erosion control bond in the amount of \$15,700 for construction of the manufacturing annex building.
