Angie Parkinson inquired on the progress of the new Senior Center. Mayor Leclerc reported that the senior center is currently under budget, last minute items such as furniture and plantings remain. A grand opening is expected sometime in 2021.

OPPORTUNITY FOR RESIDENTS TO SPEAK

Mayor Leclerc commented on the following: (1) noted that vaccines for Covid-19 had been distributed to about 20% of firefighters who are the first responders in East Hartford. Unfortunately police are not considered first responders but the Administration is looking at ways in which we can have the police vaccinated; (2) the Town received \$811,000 from the state through the CARES federal funding which will offset increased pandemic costs associated with testing, FMLA paid leave and other expenses; and (3) Frank Collins, long time Economic Development Commission member, Rotarian and Chamber of Commerce member, has passed away. The Mayor noted his incredible decades of service to the town:

<u>Chair Kehoe</u> and <u>Councillors Clarke and Martin</u> noted their positive interactions with Frank and his commitment to the community. The Chair called for a moment of silence to honor the passing of Frank Collins.

The Town Council originally set the fees for bulky waste permits more than 10 years ago. The fee structure and amounts have not been reviewed since that time. In particular, there is some concern that too many residents are illegally putting bulky waste to the curb without notifying the town and without having a permit, creating an unsightly mess.

The Town Council should work with the Administration to determine the best structure and amounts that are responsive to the needs of the residents of East Hartford and provide some revenue to offset the costs of disposing of such bulky waste.
