Robert Valerio, 552 Goodwin Street, spoke against the possible transfer of teachers from their under-funded pension plan to Social Security. Mr. Valerio believes that this would have an adverse effect on the town's mil rate.

Attached is a draft Town Council resolution authorizing you as Mayor to approve the use of Biometric Identification Service (BIS) which is an outside firm to provide fingerprinting services for residents at the East Hartford Police Department.

In these times with an enhanced focus on security, more and more employers and government agencies are requiring fingerprints to document an individual's identity. In 2018, the East Hartford Police Department fingerprinted approximately 700 individuals as a service to citizens.

The Department has reached out to Biometric Identification Service to provide a trained Fingerprint Technician to the East Hartford Police Department every Wednesday between 10:00AM – 2:00PM starting on March 6, 2019. This service will take place in a room adjacent to the police lobby. BIS will provide applicant fingerprinting and Notary services to any person (with proper ID) who requests such, for any purpose. While we believe that the majority of users will be from East Hartford, the service will be open to citizens from any town, city, state or country.

There will be no cost to the Town of East Hartford or the Police Department. Users are charged \$25.00 for this service, payable to BIS, which covers the cost of the service.

BIS maintains in full force (and agrees to maintain) a full package of insurance that includes Liability, Vehicle, Workers Compensation, Errors and Omissions and Property coverage. BIS Personnel are fully covered by BIS insurance while on-site at any of their applicant fingerprinting locations.

Using the service that BIS provides will free up officers so they can be deployed to address more serious law enforcement issues. BIS currently provides fingerprinting services to 14 other law enforcement agencies throughout the state, including Hartford PD, Manchester PD, South Windsor PD, New Britain PD Windsor PD and UConn PD.

### **Law Enforcement Agency Agreement**

### **Applicant Fingerprinting Services**

### 1. Intent of Agreement

The intent of this Agreement between Biometric Identification Services, LLC (BIS) and the Town of East Hartford, (Agency) is to establish what services will be provided by BIS to the Agency, requirements of the Agency to support BIS services (ie: space to provide services, electrical outlet, etc), costs, insurance coverage and other information.

#### 2. Services to be Provided

Services to be provided include travel to agency's site on agreed upon day(s) and time(s), provide a trained Fingerprint Technician along with FBI Certified Electronic Live Scan Equipment (unless provided by agency), identification verification of applicant (government issued photo ID), demographic data entry, electronic fingerprint capture and printing of Connecticut, FBI and/or other fingerprint cards. (Electronic submission will also be available once the State of Connecticut completes necessary secured transmission means.) Notary Public services are also available.

### 3. Services Provided By

All BIS services are provided by experienced law enforcement (or related field) and/or trained fingerprinting personnel. All employees are background checked and will report for services in BIS attire with proper identification.

### 4. Service Availability

BIS will provide applicant fingerprinting and Notary services to any person (with proper ID) who requests such, for any purpose and from any town, city, state or country. (We do not restrict services to Agency's residents.)

### 5. Costs

There is no cost to law enforcement agencies for our services. Applicants are charged a fee that is agreed upon by both BIS and the Agency.

#### 6. Insurance

BIS maintains in full force (and agrees to maintain) a full package of insurance that includes Liability, Vehicle, Workers Compensation, Errors and Omissions and Property coverage pursuant to Schedule A of this agreement. (Copies of these policies are available upon request.) BIS Personnel are fully covered by BIS insurance while on-site at any of our applicant fingerprinting locations. BIS agrees to defend, indemnify and hold Agency and its officers, employees, elected officials, and representatives harmless from any liability, loss, costs, claims or damages associated with BIS's provision of services hereunder.

A Certificate of Insurance has been issued listing the Agency as an Additional Insured and a copy of this (with applicable coverages) is attached to this Agreement pursuant to Schedule A of this Agreement.

### 7. Agency Requirements

In order for BIS to successfully provide our professional electronic applicant fingerprinting services, a designated and adequate space is required (approx 10'X10') in an area that is accessible to the public (typically a police lobby area or a room adjacent to the lobby area). One 110 Volt outlet is needed in this area to provide for electronic equipment connection. Any needed chairs, tables, connection cords and all fingerprinting equipment (including fingerprint cards) is provided by BIS. In agencies where Live Scan Device and designated area are provided, BIS personnel will utilize that designated area.

### 8. Days/Times of Services

BIS and the Agency will agree to day(s) of the week and time(s) of the day for services to be performed. Day(s) and time(s) will be the same weekly and BIS will provide services on all days as scheduled unless the days: a. fall on a State holiday, b. inclement weather prevents our technicians from safely arriving at Agency site, c. other circumstances beyond the control of BIS prevent services from taking place. (Service day(s) and time(s) can be adjusted as appropriate by agreement of BIS and Agency.)

### 9. Group Fingerprinting

BIS, in addition to providing law enforcement agencies with services, specializes in on-site fingerprinting services for larger groups at their locations. This includes school bus companies, tutoring agencies, day care facilities, banks, hospitals, etc. In an effort to prevent backlogs and lines at the Agency due to a large group requesting fingerprinting, BIS requests the right to offer on-site services to these groups.

### 10. Rejected Fingerprint Cards

BIS is fully responsible for any and all rejected fingerprint cards to the State, FBI or other entities and re-fingerprinting will be conducted at no cost to the applicant. The applicant can return to the Agency or go to any of our fingerprinting locations.

### 11. Police Officer Applicants/Agency Employees

BIS will provide fingerprinting and Notary services to Agency Police Officer Applicants or Agency Employees at no charge.

### 12. Termination of Services

This Agreement between BIS and the Agency can be terminated by either party with 60 day notice.



### Fingerprinting Statement of Services and Waiver of Liability

The applicant, whose fingerprints are being taken by a representative of Biometric Identification Services, LLC (BIS), hereby acknowledges that the services being provided include the following:

Identification verification, electronic or inked fingerprint capture, electronic or manual data entry, and printing of completed cards or electronic submission. Our services do not include receiving results of any submitted fingerprint cards for criminal background checks. This information will be forwarded to the person or entity designated by the applicant directly from the State and/or the Federal Bureau of Investigation (FBI).

The applicant, whose fingerprints are being taken by a representative of Biometric Identification Services, LLC (BIS), understands that the fee being paid for fingerprinting services is strictly as detailed above and does not include any State or FBI fees that may be required by law. Additionally, the applicant agrees that BIS and its representatives are only responsible for reviewing any forms of identification presented by the applicant and making a reasonable determination that the applicant is who they say they are from the information presented. BIS and its representatives reserve the right to refuse fingerprinting services to an individual if sufficient and positive forms of identification are not provided prior to services being completed. The applicant also agrees to hold BIS and any of its representatives harmless in the event that any criminal history is disclosed as a result of any submitted fingerprint images as well as for any errors or omissions from governmental agencies.
