OPPORTUNITY FOR RESIDENTS TO SPEAK

NEW BUSINESS

Chair Bell stated that the purpose of this meeting is to discuss how the Council can take a more active role in thoughtfully engaging with Town residents. As the Town has transitioned from the pandemic, the goal of the Committee is to develop creative ways to interact with constituents and share information. The Committee discussed establishing a more structured schedule of meetings starting in March and convening on a quarterly basis.

Previous discussion in May included ideas such as a "Walk Across East Hartford" and a "Coffee with the Councillors" as ways to meet residents and interact outside of formal meetings and engagements.

The Committee discussed ways to allow for residents to more easily identify the Council at social functions through branding such as Town Council t-shirts or large buttons that can be worn as markers to the community. As the committee does not have a formal budget, funds would need to be allocated from the department. Items such as these would help Council members stand out in crowds and encourage approachability from residents.

The Committee discussed details for hosting walks across East Hartford in the Spring. Logistics regarding safety of residents, ideal locations for engagement and availability of Council members and staff were discussed. It was agreed that these events would be most beneficial if scheduled on a regular basis and once weather was more ideal for outdoor activities.

The Parks and Recreation Department has considered hosting weekly fun runs at various parks throughout Town which could also provide the Council with an opportunity to attend and share information with residents that is timely and aligns with goals of the Administration, such as brochures to promote participation in Town Boards and Commissions or links to various resources currently available to residents. The Committee concurred that any such materials be made available in both English and Spanish and also could include QR codes to help direct residents to additional relevant information on the Town's website.
