RESOLUTION APPROPRIATING \$15,000,000 FOR THE PLANNING, DESIGN, CONSTRUCTION AND RECONSTRUCTION OF TOWN ROADS AND PARKING LOTS AND FOR FLOOD CONTROL SYSTEM IMPROVEMENTS AND AUTHORIZING THE ISSUANCE OF \$15,000,000 BONDS OF THE TOWN TO MEET SAID APPROPRIATION AND PENDING THE ISSUANCE THEREOF THE MAKING OF TEMPORARY BORROWINGS FOR SUCH PURPOSE

Section 1. The Town of East Hartford, Connecticut (the "Town") hereby appropriates (a) \$10,000,000 for the planning, design, construction and reconstruction of Town roads and parking lots, including rebuilding, resurfacing, drainage, conduits, and related subsurface and infrastructure improvements, and (b) \$5,000,000 for flood control system improvements, including, but not limited to, bringing the system into conformity with federally mandated standards imposed on the Town by the U.S. Army Corps of Engineers, inclusive of administrative, legal and financing costs related thereto (the "Projects").

To meet said appropriation, \$15,000,000 bonds of the Town or so much thereof as Section 2. shall be necessary for such purpose, shall be issued, maturing not later than the tenth year after their date. Said bonds may be issued in one or more series as determined by the Mayor, the Treasurer and Director of Finance in the amount necessary to meet the Town's share of the cost of the Projects, provided that the total amount of bonds to be issued shall not be less than an amount which will provide funds sufficient with other funds available for such purpose to pay the principal of and the interest on all temporary borrowings in anticipation of the receipt of the proceeds of said bonds outstanding at the time of the issuance thereof, and to pay for the administrative, legal and financing costs of issuing said bonds. The bonds shall be in the denomination of \$1,000 or any whole multiple thereof, be issued fully registered form, be executed in the name and on behalf of the Town by the facsimile or manual signatures of the Mayor and the Treasurer, bear the Town seal or a facsimile thereof, be certified by a bank or trust company which bank or trust company may be designated the registrar and transfer agent, be payable at a bank or trust company and be approved as to their legality by Robinson & Cole LLP, Attorneys-at-Law, of Hartford, Connecticut. The bonds shall be general obligations of the Town and each of the bonds shall recite that every requirement of law relating to its issue has been duly complied with, that such bond is within every debt and other limit prescribed by law, and that the full faith and credit of the Town are pledged to the payment of the principal thereof and interest thereon. The aggregate principal amount of the bonds of each series to be issued, the annual installments of principal, redemption provisions, if any, the certifying, registrar and transfer agent and paying agent, the date, time of issue and sale and other terms, details and particulars of such bonds, including approval of the rate or rates of interest, shall be determined by the Mayor, the Treasurer and the Director of Finance in accordance with the General Statutes of Connecticut, Revision of 1958, as amended from time to time (the "Connecticut General Statutes").

Section 3. Said bonds shall be sold by the Mayor, the Treasurer and the Director of Finance in a competitive offering or by negotiation, in their discretion. If sold in a competitive offering, the bonds shall be sold at not less than par and accrued interest on the basis of the lowest net or true interest cost to the Town. A notice of sale or a summary thereof describing the bonds and setting forth the terms and conditions of the sale shall be published at least five days in advance of the sale in a recognized publication carrying municipal bond notices and devoted primarily to financial news and the subject of state and municipal bonds. If the bonds are sold by negotiation, provisions of the purchase agreement shall be approved by the Mayor, the Treasurer and the Director of Finance.

Section 4. The Mayor, the Treasurer and the Director of Finance are authorized to make temporary borrowings in anticipation of the receipt of the proceeds of said bonds. Notes evidencing such borrowings shall be signed by the Mayor and the Treasurer, have the seal of the Town affixed, be payable at a bank or trust company designated by the Mayor, the Treasurer and the Director of Finance, be approved as to their legality by Robinson & Cole LLP, Attorneys-at-Law, of Hartford, Connecticut, and be certified by a bank or trust company designated by the Mayor, the Treasurer and the Director of Finance pursuant to Section 7-373 of the Connecticut General Statutes. They shall be issued with maturity dates which comply with the provisions of the Connecticut General Statutes governing the issuance of such notes. The notes shall be general obligations of the Town and each of the notes shall recite that every requirement of law relating to its issue has been duly complied with, that such note is within every debt and other limit prescribed by law, and that the full faith and credit of the Town are pledged to the payment of the principal thereof and the interest thereon. The net interest cost on

such notes, including renewals thereof, and the expense of preparing, issuing and marketing them, to the extent paid from the proceeds of such renewals or said bonds, shall be included as a cost of the Projects. Upon the sale of the bonds, the proceeds thereof, to the extent required, shall be applied forthwith to the payment of the principal of and the interest on any such notes then outstanding or shall be deposited with a bank or trust company in trust for such purpose.

Section 5. The balance of any appropriation or the proceeds of any bonds not needed to meet the cost of any Project authorized by this resolution may be transferred with the approval of the Town Council to meet the actual cost of any other Project authorized by this resolution; provided that the aggregate amount of bonds authorized pursuant to such transfer shall not be increased.

Section 6. The Town hereby expresses its official intent pursuant to Section 1.150-2 of the Federal Income Tax Regulations, Title 26 (the "Regulations"), to reimburse expenditures paid sixty days prior to and anytime after the date of passage of this resolution in the maximum amount of the Projects with the proceeds of bonds, notes or other obligations ("Tax Exempt Obligations") authorized to be issued by the Town. The Tax Exempt Obligations shall be issued to reimburse such expenditures not later than 18 months after the later of the date of the expenditure or the substantial completion of the Projects, or such later date the Regulations may authorize. The Town hereby certifies that the intention to reimburse as expressed herein is based upon its reasonable expectations as of this date. The Director of Finance or his designee is authorized to pay Project expenses in accordance herewith pending the issuance of the Tax Exempt Obligations.

Section 7. The Mayor, the Treasurer and the Director of Finance are hereby authorized, on behalf of the Town, to enter into agreements or otherwise covenant for the benefit of bondholders to provide information on an annual or other periodic basis to Municipal Securities Rulemaking Board (the "MSRB") and to provide notices to the MSRB of certain events as enumerated in Securities and Exchange Commission Exchange Act Rule 15c2-12, as amended, as may be necessary, appropriate or desirable to effect the sale of the bonds and notes authorized by this resolution. Any agreements or representations to provide information to MSRB made prior hereto are hereby confirmed, ratified and approved.

Section 8. The Mayor, the Treasurer and the Director of Finance are hereby, authorized, on behalf of the Town, to enter into any other agreements, instruments, documents and certificates, including tax and investment agreements, for the consummation of the transactions contemplated by this resolution. The Mayor, the Treasurer and the Director of Finance are hereby authorized, on behalf of the Town, to apply for and accept any and all Federal and State loans and or grants-in-aid of any Project, to expend said funds in accordance with the terms hereof, and in connection therewith to contract in the name of the Town with engineers, contractors and others.

BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF EAST HARTFORD:

Section 1. The sum of \$5,000,000 is appropriated by the Town of East Hartford, Connecticut (the "Town") for the planning, design, acquisition, construction and/or renovation of a Senior Center/Multipurpose Facility, and for administrative, legal and financing costs related thereto (the "Project").

To meet said appropriation, \$5,000,000 bonds of the Town or so much thereof as shall be Section 2. necessary for such purpose, shall be issued, maturing not later than the tenth year after their date. Said bonds may be issued in one or more series as determined by the Mayor, the Treasurer and the Director of Finance in the amount necessary to meet the Town's share of the cost of the Project, provided that the total amount of bonds to be issued shall not be less than an amount which will provide funds sufficient with other funds available for such purpose to pay the principal of and the interest on all temporary borrowings in anticipation of the receipt of the proceeds of said bonds outstanding at the time of the issuance thereof, and to pay for the administrative, legal and financing costs of issuing said bonds. WHEREAS, the Town of East Hartford, Connecticut (the "Town") considers any level of unemployment unreasonable and any obsolete residential, industrial, commercial and manufacturing facilities unacceptable, and continually seeks innovative approaches to attracting jobs to the Town, constructing and holding residential, non-residential, industrial, commercial and manufacturing facilities, and eliminating vacant facilities which are a blighting influence; and

WHEREAS, the ordinary operations of private enterprise cannot deal effectively with these problems without the powers provided under the Act, and the exercise of the powers conferred upon the Town by the Act are critical to revitalizing the Town; and

WHEREAS, the members of the Town Council have general knowledge of the conditions within the Town relating to the rate of unemployment, the obsolescence of many of the Town's residential, commercial, industrial and manufacturing facilities and the need for the Town to retain and attract new residential, commercial, industrial and manufacturing facilities; and

- (1) it is unreasonable that any number of residents of the Town are subject to hardship in finding employment and adequate, safe and sanitary housing;
- (2) any conditions of blight and deterioration that exist in the Town must be addressed;
- (3) private enterprise is not meeting such need for housing, employment, and the reduction of blight and deterioration;
- (4) the need for employment and adequate, safe and sanitary housing will be lessened and the Town will be revitalized by the exercise of the powers granted under the Act;

- (8) the acquisition or disposition of all development property shall advance the public interest, general health, safety and welfare, and development, growth and prosperity of the Town.

Section 1. The sum of \$3,000,000 is appropriated by the Town of East Hartford, Connecticut (the "Town"), subject to Town Council approval for such appropriations, for land acquisition and infrastructure improvements for redevelopment of the Silver Lane Corridor, bounded on the east by Forbes Street, on the north by Interstate 84, on the south by a line drawn parallel to Silver Lane from the southerly extension of any parcel with access to Silver Lane and to the west by Mercer Avenue and the high occupancy vehicle exit from Interstate 84 to Silver Lane, provided that such corridor shall not include the property known as Rentschler Field, including, but not limited to, environmental testing and remediation, acquisition, demolition and improvement of land and existing buildings for resale to developers or retained for open space, and installation of roads, sidewalks, sewers, drainage, lighting, landscaping, and other public improvements, and for administrative, legal and financing costs related thereto (the "Project").

Section 1. Not exceeding \$8,000,000 General Obligation Refunding Bonds (the "Refunding Bonds") of the Town of East Hartford, Connecticut (the "Town") may be issued in one or more series and in such principal amounts as the Mayor, Town Treasurer and the Director of Finance shall determine to be in the best interests of the Town for the purpose of achieving net present value savings and/or to moderate debt service payments. The Refunding Bonds shall bear interest payable at such rate or rates as shall be determined by the Mayor, the Town Treasurer and the Director of Finance. The Refunding Bonds shall be executed in the name and on behalf of the Town by the manual or facsimile signatures of the Mayor, the Town Treasurer and the Director of Finance, bear the Town seal or a facsimile thereof, and be approved as to their legality by Robinson & Cole LLP, Bond Counsel. The Refunding Bonds shall be general obligations of the Town and each of the Refunding Bonds shall recite that every requirement of law relating to its issue has been duly complied with, that such bond is within every debt and other limit prescribed by law, and that the full faith and credit of the Town are pledged to the payment of the principal thereof and the interest thereon. The aggregate denominations, form, details, and other particulars thereof, including the terms of any rights of redemption and redemption prices, the designation of the certifying, paying, registrar and transfer agent, shall be subject to the approval of the Mayor, the Town Treasurer and the Director of Finance. The net proceeds of the sale of the Refunding Bonds, after payment of underwriter's discount and other costs of issuance, shall be deposited in an irrevocable escrow account in an amount sufficient to pay the principal of, interest and redemption premium, if any, due on the Refunded Bonds to maturity or earlier redemption pursuant to the plan of refunding. 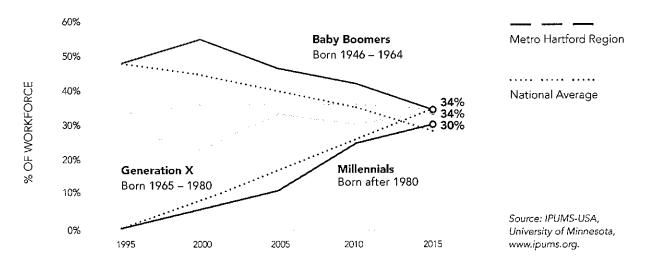

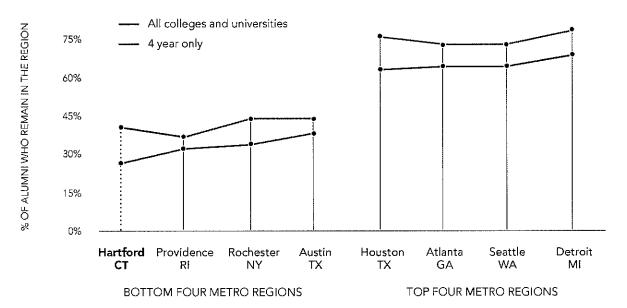
NEIGHBORHOODS BY OPPORTUNITY LEVEL

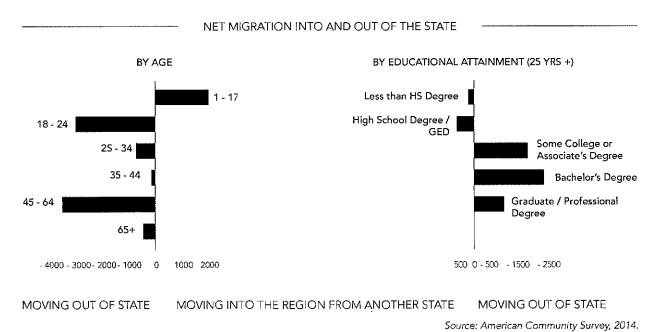

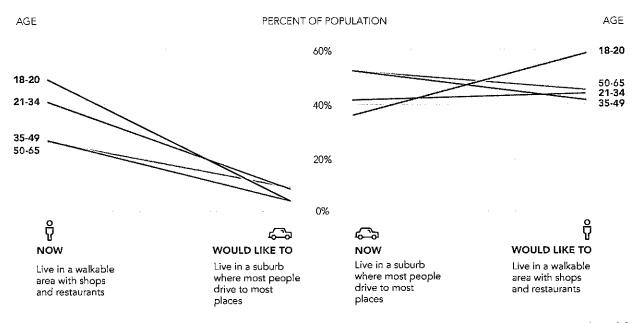

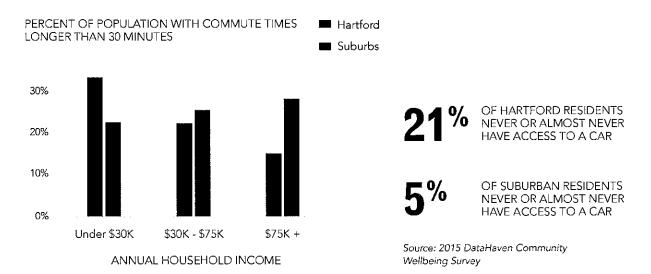

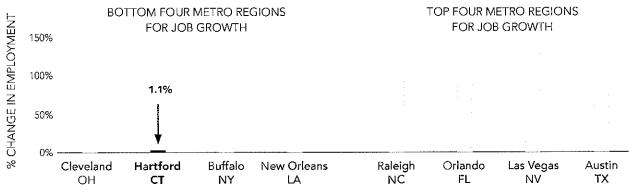

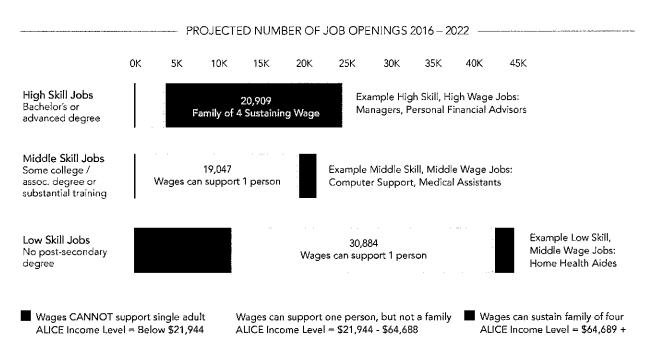

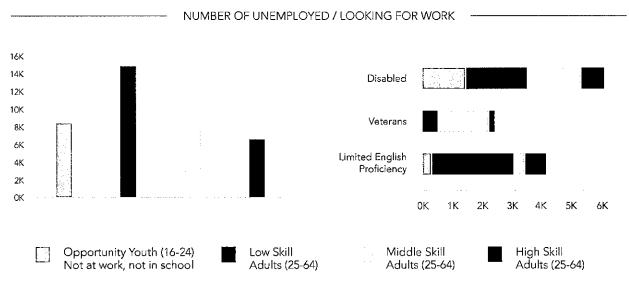

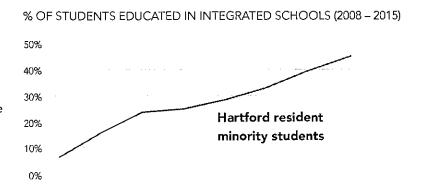

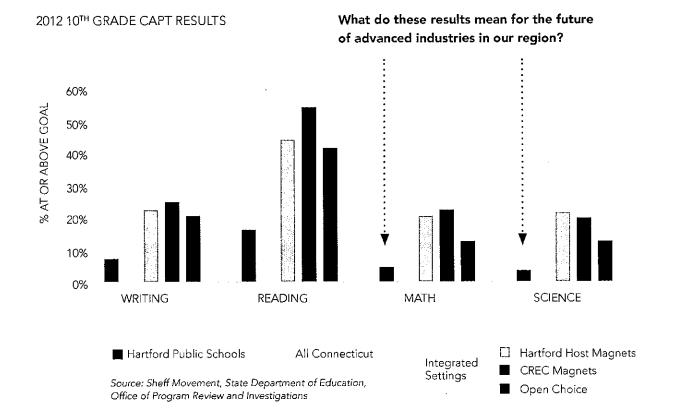

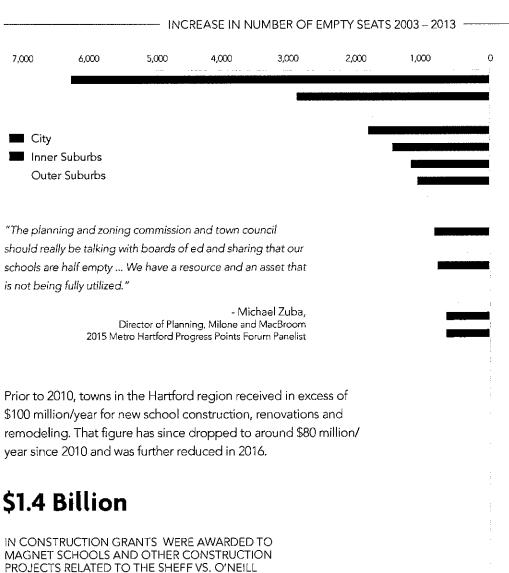

RE: Water Resources Reform and Development Act of 2014

Section 7001 Report

The Water Resources Reform and Development Act (WRRDA) of 2014 was signed into law on June 10, 2014. WRRDA is the primary legislation by which Congress authorizes the United States Army Corps of Engineers' (USACE) to complete its key civil works missions, navigation, flood risk management and environmental restoration. The authorities provided in WRRDA help USACE continue to provide assistance in developing and maintaining the nation's waterways and harbors, reducing damages from storm events, and restoring the environment. WRRDA is strictly an authorizing legislation; it does not include funding. The funding of WRRDA-authorized studies and projects is accomplished separately as part of the annual appropriations process.

Section 7001 of WRRDA 2014 requires that the Secretary of the Army annually submit to the Congress a report that identifies, for potential congressional authorization, completed feasibility reports, proposed feasibility studies, and proposed modifications to authorized projects or studies that meet all the following criteria:

- Are related to the missions and authorities of the USACE. The USACE primary missions are navigation, flood risk management, and aquatic ecosystem restoration. Recreation, hydropower and/or water supply will be considered "related" when it is performed in conjunction with one or more of the primary mission(s).
- Require specific congressional authorization.
- Have not been congressionally authorized.
- Have not been included in the main table of a previous annual report.
- If authorized could be carried out by the USACE.

The annual Report to Congress on Future Water Resources Development is based, in part, upon annual requests for proposals for authorization from non-Federal interests for <u>proposed</u> <u>feasibility studies and proposed modifications to authorized projects or studies</u> that require authorization for the USACE to proceed.

Section 7001 requires that the Secretary certify that the proposals included in the annual report meet the criteria established by Congress, listed above. Any proposals that do not meet the criteria will be included in the Report's appendix. Inclusion in the Annual Report to Congress does not provide authorization or appropriation for a study or project.

Repair and maintenance activities do not fall under the USACE's authority as established by Congress. Any non-Federal submission for inclusion in the annual section 7001 Report which involves maintenance activities will be included in the appendix of the section 7001 report as specified by Congress.

Public Works plans on submitting the two requests noted below to the USACE for inclusion in upcoming annual section 7001 Report for the flood protection system.

- 1. A rehabilitation study of the interior drainage system, three storm water pump stations, associated levee penetrations, and the Meadow Hill storage pond. The study would include an evaluation of the existing facilities and operations. Consideration would be given for various alternatives for rehabilitation, modification and /or upgrades to the System during the development of a facilities plan. The original layout of the Meadow Hill storm water storage pond would be evaluated to include a review of the operation and potential design modifications to improve sedimentation management as well the impacts of the tidal influences of the Connecticut River.
- 2. Assistance in the rehabilitation of the Town's flood reduction system. The project would involve improvements in four major categories which include the following:
 - a. Structural improvements including closure structure upgrades, toe & collector drain upgrades / replacement, and repairs to a concrete box culvert levee penetration.
 - b. Improvements to the interior storm drainage system including the dredging of the Meadow Hill storage pond.
 - c. Renovations and upgrades to the three stormwater pump stations
 - d. Operational improvements throughout the system to assist in the maintenance and operation of the levee system.

The second request does not fall within the USACE's authority. Based on the Congressional requirements associated with WRRDA, the Town's second request will not be included in the body of the 7001 Report but will be included in the Report's appendix. The intent of the request is ensure that Congress is aware of the Town's efforts expended on rehabilitating the flood protection system as well as documenting the Town's financial need to complete the project.

The submission of these application is online and due no later than September 19, 2016, and must include a letter of support from the Town for each proposal.

Attached is a draft resolution authorizing you as Mayor to submit project authorization requests (including letters of support) to the U.S. Army Corps of Engineers (USACE) as a prerequisite to seeking funding for the East Hartford Flood Protection System Rehabilitation Project under the Federal Water Resources Reform and Development Act (WRDA).

The USACE has provided an opportunity for towns to initiate the process of seeking funds for important local water projects. The first step is to submit requests for project authorizations that are compiled by USACE, put in a single report and submitted to Congress.

The first request will be for a rehabilitation study associated with the three storm water pump stations and the redesign of the Meadow Hill storage pond. The preliminary cost of the study is \$2,000,000 which has a 50% local share (\$1,000,000). It should be noted that up to half the local share (\$500,000) can be provided as an in-kind (noncash) contribution.

The second request will be for the rehabilitation of the Flood Protection System which includes construction funding. The project would include the following:

- replacement of the toe drains as well as various collector drains;
- replacement / renovation of the three storm water pump stations;
- dredging of the Meadow Hill storage pond;
- renovation of the two closure structures;
- various operational improvements to the system

The total estimated cost for the second \$19,010,000. For projects of this nature, the USACE requires a 35 percent local match (approximately \$6,653,500).

Please note that this submission is not a request for permission to do the work, nor is it a request for funding to do the work or a commitment of matching funds. The goal is to get these projects into the report that will be submitted to Congress so that, as WRDA funds are appropriated, these two projects will be among those that can be selected for funding.

Economic and Environmental Principles for Water and Related Land Resources Implementation Studies

These Principles are established pursuant to the Water Resources Planning Act of 1965 (Pub. L. 89-80), as amended (42 U.S.C. 1962a-2 and d-1). These Principles supersede the Principles established in connection with promulgation of principles, standards, and procedures at 18 CFR, Parts 711, 713, 714, and 716.

1. Purpose and Scope

These principles are intended to ensure proper and consistent planning by Federal agencies in the formulation and evaluation of water and related land resources implementation studies.

Implementation studies of the following agency activities are covered by these principles:

- (a) Corps of Engineers (Civil Works) water resources project plans;
- (b) Bureau of Reclamation water resources project plans;
- (c) Tennessee Valley Authority water resources project plans;
- (d) Soil Conservation Service water resources project plans.

Implementation studies are pre- or postauthorization project formulation or evaluation studies under taken by Federal agencies.

2. Federal Objective

The Federal objective of water and related land resources project planning is to contribute to national economic development consistent with protecting the Nation's environment, pursuant to national environmental statutes, applicable executive orders, and other Federal planning requirements.

- (a) Water and related land resources project plans shall be formulated to alleviate problems and take advantage of opportunities in ways that contribute to this objective.
- (b) Contributions to national economic development (NED) are increases in the net value of the national output of goods and services, expressed in monetary units. Contributions to NED are the direct net benefits that accrue in the planning area and the rest of the Nation. Contributions to NED include increases in the net value of those goods and services that are marketed, and also of those that may not be

marketed.

3. State and Local Concerns

Federal water resources planning is to be reponsive to State and local concerns. Accordingly, State and local participation is to be encouraged in all aspects of water resources planning. Federal agencies are to contact Governors or designated State agencies for each affected State before initiating Studies, and to provide appropriate opportunities for State participation. It is recognized, however, that water projects which are local, regional, statewide, or even interstate in scope do not necessarily require a major role for the Federal Government; non-Federal, voluntary arrangements between affected jurisdictions may often be adequate. States and localities are free to initiate planning and implementation of water projects.

4. International Concerns

Federal water resources planning is to take into account international implications, including treaty obligations. Timely consultations with the relevant foreign government should be undertaken when a Federal water project is likely to have a significant impact on any land or water resources within its territorial boundaries.

5. Alternative Plans

Various alternative plans are to be formulated in a systematic manner to ensure that all reasonable alternatives are evaluated.

- (a) A plan that reasonably maximizes net national economic development benefits, consistent with the Federal objective, is to be formulated. This plan is to be identified as the NED plan.
- (b) Other plans which reduce net NED benefits in order to further address other Federal, State, local, and international concems not fully addressed by the NED plan should also be formulated.
- (c) Plans may be formulated which require changes in existing statutes, administrative regulations, and established common law; such required changes are to be identified.
- (d) Each alternative plan is to be formulated in consideration of four criteria: completeness, effectiveness, efficiency, and acceptability. Appropriate mitigation of adverse effects is to be an integral part of each alternative plan.

(e) Existing water and related land resources plans, such as State water resources plans, are to be considered as alternative plans if within the scope of the planning effort.

6. Plan Selection

A plan recommending Federal action is to be the alternative plan with the greatest net economic benefit consistent with protecting the Nation's environment (the NED plan), unless the Secretary of the department or head of an independent agency grants an exception to this rule. Exceptions may be made when there are overriding reasons for recommending another plan, based on other Federal, State, local and international concerns.

7. Accounts

Four accounts are established to facilitate evaluation and display of effects of alternative plans. The national economic development account is required. Other information that is required by law or that will have a material bearing on the decision-making process should be included in the other accounts, or in some other appropriate format used to organize information on effects.

- (a) The national economic development (NED) account displays changes in the economic value of the national output of goods and services.
- (b) The environmental quality (EQ) account displays non-monetary effects on significant natural and cultural resources.
- (c) The regional economic development (RED) account registers changes in the distribution of regional economic activity that result from each alternative plan. Evaluations of regional effects are to be carried out using nationally consistent projections of income, employment, output and population.
- (d) The other social effects (OSE) account registers plan effects from perspectives that are relevant to the planning process, but are not reflected in the other three accounts.

8. Discount Rate

Discounting is to be used to convert future monetary values to present values.

9. Period of Analysis

The period of analysis to be the same for each alternative plan.

10. Risk and Uncertainty

Planners shall identify areas of risk and uncertainty in their analysis and describe them clearly, so that decisions can be made with knowledge of the degree of reliability of the estimated benefits and costs and of the effectiveness of alternative plans.

11. Cost Allocation

For allocating total project financial costs among the purposes served by a plan, separable costs will be assigned to their respective purposes, and all joint costs will be allocated to purposes for which the plan was formulated. (Cost sharing policies for water projects will be addressed separately.)

12. Planning Guidance

In order to ensure consistency of Federal agency planning necessary for purposes of budget and policy decisions and to aid States and the public in evaluation of project alternatives, the Water Resources Council (WRC), in cooperation with the Cabinet Council on Natural Resources and Environment, shall issue standards and procedures, in the form of guidelines, implementing these Principles. The head of each Federal agency subject to this order will be responsible for consistent application of the guidelines. An agency may propose agency guidelines which differ from the guidelines issued by WRC. Such agency guidelines and suggestions for improvements in the WRC guidelines are to be submitted to WRC for review and approval. The WRC will forward all agency proposed guidelines which represent changes in established policy in the Cabinet Council on Natural Resources and Environment for its consideration.

13. Effective Date

These Principles shall apply to implementation studies completed more than 120 days after issuance of the standards and procedures referenced in Section 12, and concomitant repeal of 18 CFR, Parts 711, 713, 714, and 716.

These economic and environmental Principles are hereby approved.

1252-1256 Main Street

Mayor Leclerc initiated a discussion of the property at 1252-1256 Main Street which was marketed to the Town through Graham Real Estate. The billboard will be taken down from the property, which will greatly reduce the value of the property since this revenue stream will cease to exist. The property was described as a "rooming house" with numerous violations and an infestation of bed bugs. The Health Department has had numerous interactions at this property, as has the EHFD and EHPD. The Mayor will look into whether the taxes on the property are up to date. The seller claimed the appraised value was \$481,000 but the Town would get its own appraisal if there were interest in acquiring the parcel. Eileen Buckheit, Development Director, noted that this property falls under the redevelopment zone from when the CVS Plaza was created. Ms. Buckheit noted that the building would be difficult to rehab and would likely need to be razed. Attorney Gentile suggested that the Town learn what the listing price for the property would be, but Ms. Buckheit noted that there is not yet a listing for the property. Councillor Horan suggested looking into the cost of demolishing the property and that Attorney Gentile report back to the Committee once a listing price has been communicated to the Town. The Mayor will inquire regarding any fines owed on the property at the request of Susan Kniep.

We have been aware of the the problems posed by outdoor wood furnaces for several years and monitored their prevalence. Research demonstrates that there are adverse health effects posed by the particulate emissions of these devices.

A recent study on outdoor wood furnaces (OWFs) shows that homes as far away as 850 feet from an outdoor wood furnace are impacted by enough smoke to cause illness. Connecticut has setbacks regulations for OWFs of only 200 feet.

- NESCAUM has estimated that each OWF emits 20 times the wood smoke as one certified indoor wood stove. NESCAUM is an association of air quality agencies in the Northeast. Their Board of Directors consists of the air directors of the six New England states Connecticut, Maine, Massachusetts, New Hampshire, Rhode Island, and Vermont and New Jersey, and New York. Their purpose is to provide scientific, technical, analytical, and policy support to the air quality and climate programs of the eight Northeast states.
- Although many people associate tobacco smoke with certain health risks, research
 indicates that second hand wood smoke has potentially even greater ability to
 damage health. Tobacco smoke causes damage in the body for approximately 30
 seconds after it is inhaled. Wood smoke, however, continues to be chemically active
 and cause damage to cells in the body for up to 20 minutes, or 40 times longer.
- A house as far away as 850 feet from an outdoor wood furnace (OWF) had 6 times the levels of PM 2.5 as the houses not near an outdoor wood furnace and 4 times above the levels of the EPA air standards.
- EPA defines PM 2.5 as Particle Matter less than 10 micrometers in diameter. These small particles pose a health concern because they can be inhaled into and accumulate in the respiratory system. Health studies have shown a significant association between exposure to fine particles and premature mortality. Other important effects include aggravation of respiratory and cardiovascular disease (as indicated by increased hospital admissions, emergency room visits, absences from school or work, and restricted activity days), lung disease, decreased lung function, asthma attacks, and certain cardiovascular problems such as heart attacks and cardiac arrhythmia. Individuals particularly sensitive to fine particle exposure include older adults, people with heart and lung disease, and children.

Sources of fine particles include all types of combustion activities - motor vehicles, power plants and wood burning.

A house 240 feet from OWF had 12 times the levels of PM 2.5 as the houses not near an outdoor wood furnace and 8 times above the levels of the EPA air standards.

 Both those heavily impacted homes were within the Connecticut setback regulations of 200 feet.

Conn. Gen. Stat. 22a-174k and Outdoor Wood Burning Furnaces

During the 2005 session of the General Assembly Public Act 05-227, now codified as Connecticut General Statute 22a-174k, concerning the siting of Outdoor Wood Burning Furnaces (OWFs) was signed into law.

The Conn. Gen. Stat. 22a-174k requires that any OWF constructed, installed, established, or modified after July 8th, 2005:

- Must operate only on wood that has not been chemically treated.
 - o Any other material burned in the OWF would constitute a violation of the statute.
 - o Additionally, installation and operation must be conducted in accordance with the manufacturer's written instructions provided they do not conflict with the statute.
 - o Must be located not less than 200 feet from the nearest residence not being served by the unit. (If the unit will be closer than 200 feet to the nearest residence not being served by the unit, then the OWF must not be installed).
- Must have a chimney that is more than the height of the roof peaks of residences located within 500 feet of the OWF, provided the chimney height is not more than 55 feet (This is to the actual roof peak, not the mid-line of the slope).
 - A chimney's height is limited to no more than 55 feet, from ground level, at its installed location. (If this is not more than the height of the roof peaks of residences located within 500 feet of the OWF, then the OWF must not be installed).
 - A licensed Land Surveyor or Professional Engineer would be able to provide appropriate mapping, showing both the horizontal and the vertical control measurements to all residences within the 500 foot radius required by law in order to demonstrate compliance with Conn. Gen. Stat. 22a-174k.
- Is subject to an infraction, not to exceed \$90/day, for every day of operation not in compliance with Conn. Gen. Stat. 22a-174k. Violation of this statute is listed under miscellaneous in the Judicial Infraction Schedule.

Connecticut municipalities continue to have local control of land use in and around areas with OWFs, for instance:

- Some municipalities institute summer bans, complete bans, or limit installation of OWFs within their jurisdictions. Local municipalities may choose to limit installations near schools, churches, and commercial areas as the statute only addresses set back requirements from residences.
- The installation of an OWF requires a building permit.

§ 177-37.3 Alternative energy systems.

[Added 7-27-2010; amended 10-28-2014]

A. Definitions. As used in this section, the following terms shall have the meanings indicated:

OUTDOOR WOOD-BURNING FURNACE

An accessory structure or appliance designed to be located outside living space ordinarily used for human habitation and designed to transfer or provide heat, via liquid or other means, through the burning of wood or solid waste, for heating spaces other than where such structure or appliance is located, any other structure or appliance on the premises, or for heating domestic, swimming pool, hot tub or jacuzzi water. "Outdoor wood-burning furnace" does not include a fire pit, wood-fired barbecue or chiminea.

- B. Prohibited equipment.
 - (1) Outdoor wood-burning furnaces are prohibited in all zones.

Sec. 10-47. \$5.00 Surcharge on Delinquent Motor Vehicle Payments.

Pursuant to Connecticut General Statutes Section 12-146, any person who owes past due motor vehicle property taxes to the Town of East Hartford, shall, in addition to the past due taxes, interest and penalties on each such motor vehicle, pay five dollars to the Town of East Hartford [to help defray the fee that the State of Connecticut is charging its cities and towns, pursuant to Connecticut General Statutes Section 14-33], to use the Department of Motor Vehicles' registry for tracking taxpayers who owe motor vehicle property taxes if the Town of East Hartford notified the Commissioner of Motor Vehicles of such delinquency pursuant to the provisions of Connecticut General Statutes Section 14-33.
