I have reviewed the minutes of the November 18, 2021 Personnel Appeals Board ("PAB") Meeting. At that meeting, the PAB asked our office a series of questions. The minutes made clear, however, that the PAB merely wanted "responses" not an official opinion.

Please know that the role of the Office of the Corporation Counsel is to assist boards and commissions by preparing written opinions concerning the legality, efficacy or validity of actions or positions proposed by the board or commission (see Town Charter Sections 5.1 (b) and (c)). The Charter does not contemplate that our office take the time to analyze and answer legal questions without the ability to issue a legal opinion. Merely giving "responses" to these questions creates a dynamic where our legal analysis and conclusions could be misinterpreted or ignored.
