# ADDENDUM $N^{\circ}$ . 2

Reconstruction of Brewer Street Bid No. 22-07 Project No. 42-318/Federal Aid ID: 1042(130) Project No. L042-0001

# **Issued MARCH 10, 2022**

The following summarizes revisions to the Bid Documents included in Addendum  $N^{o}$ . 2 for the Reconstruction of Brewer Street (Bid No. 22-07).

- 1. QUESTION 1: On contract drawing S-6 (sheet 150) under the Construction Sequence Stage 2 section it indicates that temporary modified riprap is to be placed between the two cofferdams. How is the furnishing, placing and removal of this material paid for?
  - a. ANSWER 1: The furnishing and placement of temporary modified riprap shall be paid for under item 0703012 Modified Riprap. Removal of temporary modified riprap shall be paid for under item 0203202 Structure Excavation Earth (Excluding Cofferdam and Dewatering).
- 2. QUESTION 2: On contract drawing S-2 (sheet 146), the section of the existing bridge indicates there is a 12" gas line and 9" gas line under the existing bridge. Contract drawings C1 and C2 along with the special provisions Vol. 2 pages 22-30 outline coordination and work associated with the 12" line. What is the disposition of the 9" line?
  - a. ANSWER 2: The 9" diameter gas line shown on Sheet No. 146 is an existing abandoned gas line that is to be removed under this project. Removal of existing line shall be in accordance with "Utility Work Breakdown Table" on Sheet No. 163.
- 3. QUESTION 3: NTC Work around existing utilities permits the contractor to only use oscillatory mode when "around existing utilities". Please define what will be considered "around existing utilities". Will the entirety of the subbase, processed, and asphalt items be required to be installed with oscillating rollers only?
  - a. ANSWER 3: As noted at the pre-bid meeting held on February 16, 2022, the "NTC Work Around Existing Utilities" was primarily added to the contract for the protection of MDC facilities (water mains and shallow sections of sanitary sewer). After further review with MDC, the following provides additional clarification:

- *i.* West of Glenn Road: The use of rollers in vibratory mode shall not be used for roadway reconstruction (subbase, processed and bituminous items).
- *ii.* East of Glenn Road: The use of rollers in vibratory mode shall not be used for roadway boxout (subbase and processed) when within 25' of the watermain. The use of rollers in vibratory mode may be used for the bituminous items.

As stated in the NTC, all work occurring near the existing utilities shall be coordinated with the utility owner.
