Work under this contract includes installation of a sewer holding tank with appropriate plumbing and monitoring system, installation of a new upflush toilet and low flow sink including appropriate plumbing and electrical wiring in the Town of East Hartford. It also includes other appurtenant work such as re-plumbing of the existing sump pump as well as the outside gutter system.

Sealed Bids will be received at the office of the Purchasing Department, Town Hall, 740 Main Street, East Hartford, CT 06108 until 11 AM, TUESDAY, OCTOBER 26, 2021 at which time and place said bids will be opened publicly and read.

The Town will conduct a NON-MANDATORY PRE-BID MEETING on THURSDAY, OCTOBER 14, 2021 AT 10 AM AT the MEADOW HILL PUMP STATION located on 143 PITKIN STREET, EAST HARTFORD, CT-06108.

IN ORDER TO BE CONSIDERED AN OFFICIAL PLAN HOLDER AND ELIGIBLE BIDDER FOR THE PROJECT, THE PURCHASING AGENT MUST RECEIVE AN EMAIL indicating interest in bidding, company information, and main contact information on, or before, MONDAY, OCTOBER 18, 2021. All companies that send a representative to the non-mandatory pre-bid meeting or register on the Town's website to download the documents will also be considered an official plan holder eligible to bid the project.

Requests for information (RFIs) will be accepted via email to the Purchasing Agent on or before WEDNESDAY, OCTOBER 20, 2021.

Drawings and Specifications will be available for review at the office of the Purchasing Agent, East Hartford Town Hall, 740 Main Street, East Hartford, CT. (Between the hours of 8:30 am to 4:30 pm, Monday through Friday) and on the Town of East Hartford's Purchasing Website:
