# APPLICATION INSTRUCTIONS FOR "OUTSIDE ACTIVITIES" TO BE TEMPORARILY PERMITTED UNDER EXECUTIVE ORDER NO. 7MM

The Town of East Hartford wants to help you to re-open your business as easily as possible. For businesses that serve food or sell goods and wish to conduct that activity outdoors, a permit will be required. There is no fee for this permit.

For the permit application you will be required to submit the following information:

#### **DECD SELF-CERTIFICATION**

# **PLAN**

Please submit a scaled drawing or sketch (preferably  $\frac{1}{4}$  inch = 1 foot which can be on graph paper), showing the following:

- Where the outside activity will be located.
- Arrangement and spacing of tables.
- Location of building exits if close to outside activity.
- Location of building, width of sidewalk and curb if outside activity is to be located on a sidewalk.

- Location of parking spaces or driveways if close to outside activity.
- Any barriers or means to keep outside patrons safe from motor vehicles.
- Location of trash containers.
- Location of any temporary lighting if activity will continue past dusk.

The plan will need to be submitted online as a PDF file.

#### **NARRATIVE**

In writing please describe in detail how you will manage the following issues:

- 1) Noise
- 2) Waste management (garbage and refuse)
- 3) Odor
- 4) Light pollution
- 5) Environmental impacts

# ADDITIONAL INFORMATION

Once we have reviewed the above submitted information, we may have questions or require additional information. You should very promptly supply that information so that we can issue the permit as expeditiously as possible.

# **TIMING**

The Town has 10 days from receipt of your application or the additional information to approve, approve with conditions, or reject your application. Email notification will be sent to you.
