

Dept. Organization Chart





Priorities

- New State Building Code to be adopted 7/1/18
- Update Town PMC to coordinate with State Codes
- Update Town Ordinances to coordinate with current State codes
- Upgrade online permitting to cloud-based system
- Improve integration and response with QAlert system
