

## November 6, 2018 State Election and Referendum

The Electors of the Town of East Hartford are hereby warned to meet at their respective polling places in said town on Tuesday, November 6, 2018, for the following purposes:

- I. To cast their votes for Governor and Lieutenant Governor, United States Senator, Representative in Congress, State Senator, State Representative, Secretary of the State, Treasurer, Comptroller, Attorney General, Judge of Probate, and Registrar of Voters.
- II. To vote on the following questions for the approval or disapproval of a proposed AMENDMENT to the Constitution of Connecticut, a vote of "YES" being a vote for approval, and a vote of "NO" being a vote for disapproval:
  1. Shall the Constitution of the State be amended to ensure (1) that all moneys contained in the Special Transportation Fund be used solely for transportation purposes, including the payment of debts of the state incurred for transportation purposes, and (2) that sources of funds deposited in the Special Transportation Fund be deposited in said fund so long as such sources are authorized by statute to be collected or received by the state?
  2. Shall the Constitution of the State be amended to require (1) a public hearing and the enactment of legislation limited in subject matter to the transfer, sale or disposition of state-owned or state-controlled real property or interests in real property in order for the General Assembly to require a state agency to sell, transfer or dispose of any real property or interest in real property that is under the custody or control of the agency, and (2) if such property is under the custody or control of the Department of Agriculture or the Department of Energy and Environmental Protection, that such enactment of legislation be passed by a two-thirds vote of the total membership of each house of the General Assembly?

The full text of such proposed questions with explanatory text, printed in accordance with §2-30a of the General Statutes, is available at the Town Clerk's office for public distribution.

The vote on the proposed questions is taken pursuant to the Constitution of Connecticut.

III. By way of Referendum:

"Shall the resolution entitled 'Resolution Appropriating \$3,900,000 For The Planning, Design, Replacement, Construction And Reconstruction Of Improvements To The Town Hall And Authorizing The Issuance Of \$3,900,000 Bonds Of The Town To Meet Said Appropriation And Pending The Issuance Thereof The Making Of Temporary Borrowings For Such Purpose', adopted by the Town Council on August 21, 2018, be approved?"

The ballot label for said question shall read as follows:

3. Shall the \$3,900,000 appropriation and bond authorization for the planning, design, replacement, construction and reconstruction of improvements to the Town Hall be approved?

"Shall the resolution entitled 'Resolution Appropriating \$15,000,000 For The Planning, Design, Construction And Reconstruction Of Town Roads And Parking Lots And Authorizing The Issuance Of \$15,000,000 Bonds Of The Town To Meet Said Appropriation And Pending The Issuance Thereof The Making Of Temporary Borrowings For Such Purpose', adopted by the Town Council on August 21, 2018, be approved?"

The ballot label for said question shall read as follows:

4. Shall the \$15,000,000 appropriation and bond authorization for the planning, design, construction and reconstruction of Town roads and parking lots be approved?

The vote on the aforesaid bond resolution is taken under the authority of Chapter VI, Section 6.9 of the Charter of the Town of East Hartford, and Chapter 152 of the Connecticut General Statutes, as amended.

The full text of the aforesaid resolutions is on file, open to public inspection, in the office of the Town Clerk.

The voting will be by optical voting tabulator. Those desiring to vote for a resolution shall fill in the oval over the question on the optical voting tabulator at "YES". Those desiring to vote against a resolution shall fill in the oval over the question on the optical voting tabulator at "NO".

Absentee ballots will be available as provided by law in the office of the Town Clerk.
