#### COMMUNICATIONS AND PETITIONS

Update by the EHPD: Police Cameras

Lt. Donald Olson, along with Deputy Chief Robert Davis and Detective Jason Smola, the Project Manager for the cameras, outlined the implementation of police cameras in certain areas of town. Some cameras would cover an intersection; others would have a 360-degree range and others could be adjusted remotely. The Council expressed a desire to enact regulations to govern the use of the cameras and protect privacy concerns.

#### Pension Valuation and Investment Results Presentations:

<u>Lee Griffin</u>, Town Treasurer and Chair of the Pension & Retiree Benefit Board (Pension Board), suggested that, in the interest of time, the meeting should proceed directly to the presentations.

## DiMeo Schneider & Associates, LLC: Discussion of Town's Portfolio - Fixed Income Side

<u>Christopher Kachmar</u>; Chief Investment Officer of Fiduciary Investment Advisors (FIA) addressed the Council on the annual investment returns of the fixed income portion of the Town's pension and OPEB trust funds.

#### 3D/L Capital Management: Discussion of the Town's Portfolio - Equity Side

John O'Connor, President of 3D/L Capital Management, Inc., and Ben Lavine, Chief Investment Officer of 3D/L Capital Management, Inc., presented the investment returns on the equity portion of the Town's pension and OPEB portfolio for the period from July 1, 2019 through June 30, 20209. 3D/L manages three accounts for the town: Pension Equity Account – which is a stock account, Other Post-Employment Benefits (OPEB) and a cash management account.

#### Segal Company: Pension Contributions for FY 2021-2022

Henry Nearing, Plan Actuary, reported that the Actuarially Determined Contribution (ADC) for FY2021-2022, after employee contributions, a 7.5% discount rate and a 31/4% amortization increase, is \$18,964,310. He also reported that as of June 30, 2020 there are \$22M in investment losses to be reflected in future years with the majority of these losses (\$17M) caused by the 2019-2020 plan year.
